#### O PROHIBITED ARTICLES

- ① Narcotic drugs, stimulants, marijuana, psychotropic substances, MDMA etc.
- 2 Firearms such as pistols, revolvers and machine guns, and bullets or parts thereof.
- 3 Explosives, gunpowder, materials for chemical weapons, germs such as anthrax, etc.
- 4 Counterfeit, altered or imitated coins, bank notes or securities, and forged credit cards.
- (5) Obscene or immoral materials, and child pornography.
- 6 Articles which infringe upon intellectual property rights. (patent, utility model,design, trademark, copyright, neighboring right, etc.)

### © RESTRICTED ARTICLES

- ① Hunting guns, air guns, swords, etc.
- ② Internationally protected endangered animals, plants, or their products. (crocodiles, cobras, turtles, ivory, musk, cactus, etc.)
- ③ Live animals and plants, meat products (including sausage etc), vegetables fruits, rice etc. (Quarantine inspection is required prior to Customs inspection.)

# O Duty-Free Allowance (excluding crew member)

- •3 bottles (760ml/bottle) of alcoholic beverages,
- 400 cigarettes (If you are a Japanese resident, please contact a Customs officer
- \* There is no duty-free allowance for alcoholic beverages and tobacco products for those under 20 years old.
- •2 ounces of perfume
- · Goods for personal use that were purchased abroad with a total market value not exceeding ¥200,000.
- \*When the price of an article exceeds \quantum 200,000, duties and/or taxes will be imposed on
- \* As for children under 6 years old, duty-free allowances are limited to the articles owned for their personal use.
